KY MASTER LOGGER PROGRAM

NOXIOUS WEED SPRAY PROGRAM

Each year, the Ky Department of Agriculture



offers the "Noxious Weed Spray Program" to farmers across Kentucky.

The guidelines are the same as the last few years:

OF AGRICULTURE

• KDA furnishes the chemical for

demonstrations on seven (7) farms per county

- Chemical will be supplied for 10 acres, to be sprayed with 2,4-D
- Application is performed with a twowheeled trailer type sprayer equipped with boomless nozzles
- If additional 2.,4-D chemical is provided by the participant, an additional 10 acres can be treated
- The participant must provide water source
- The participant must provide tractor and operator
- All chemical products must be labeled and the product label will be strictly followed

 Any farm or farm owner that has participated in the last 3 years is ineligible to participate

This program is designed to target weeds that have a negative impact on the participant's agricultural production, such as thistles, buttercup, etc... There will be an annual online application period to participate in this program. You may submit an application using the on-line services until February 28th. The application is located at:
